The primary surgical intervention for severe CAD is Coronary Artery Bypass Grafting (CABG).

Coronary Artery Bypass Grafting (CABG): This life-saving procedure involves creating new pathways for blood to flow to the heart muscle, bypassing the blocked sections of the coronary arteries. Surgeons use healthy blood vessels, typically harvested from the leg (saphenous vein), chest (internal mammary artery), or arm (radial artery), to create these grafts. CABG is a highly effective treatment for re-establishing adequate blood supply to the myocardium, significantly reducing the risk of heart attack and improving exercise tolerance.

Heart Valve Disease

The heart has four valves – aortic, mitral, tricuspid, and pulmonary – that ensure blood flows in the correct direction. When these valves become damaged or diseased, they can either fail to open properly (stenosis) or fail to close completely (regurgitation), impairing the heart's pumping efficiency. **Heart valve repair surgery** and **heart valve replacement surgery** are the main surgical solutions.

Heart Valve Repair: Whenever possible, surgeons prefer to repair damaged valves. Techniques vary

depending on the valve and the specific defect, and may involve reshaping leaflets, reinforcing supporting structures, or closing holes. Valve repair preserves the natural valve, which often leads to better long-term outcomes and avoids the need for lifelong anticoagulation therapy, a significant advantage over replacement.

Heart Valve Replacement: If repair is not feasible, the diseased valve is replaced with an artificial one. These can be either mechanical valves, made of durable materials like titanium and pyrolytic carbon, or biological valves, derived from animal tissue (porcine or bovine) or human donor valves. The choice between mechanical and biological valves depends on factors such as the patient's age, lifestyle, and risk factors for blood clots. Mechanical valves offer excellent durability but require lifelong anticoagulation with medications like warfarin. Biological valves do not typically require anticoagulation but have a limited lifespan and may need to be replaced in the future.

Aortic Aneurysm and Dissection

An aortic aneurysm is a bulging or ballooning of the aorta, the body's largest artery. If this bulge ruptures, it can be life-threatening. An aortic dissection occurs when a tear in the inner layer of the aorta allows blood to flow between the layers, potentially leading to rupture or obstruction of blood flow to vital organs. Surgical intervention, often involving the replacement of the affected aortic segment with a synthetic graft, is crucial for managing these conditions.

Arrhythmias

While many arrhythmias (irregular heartbeats) can be managed with medication or minimally invasive procedures like ablations, severe or refractory arrhythmias may necessitate surgical intervention. Procedures like the Maze procedure can be performed to create new electrical pathways in the heart, restoring a normal rhythm.

Congenital Heart Defects

These are structural abnormalities of the heart that are present at birth. They range in severity and can affect the heart walls, valves, or blood vessels. Surgical correction is often necessary to improve blood flow and oxygenation. Examples include atrial septal defects (ASD), ventricular septal defects (VSD), and tetralogy of Fallot.

Atrial and Ventricular Septal Defect Repair: These procedures involve closing holes in the walls separating the atria or ventricles, respectively, to prevent the mixing of oxygenated and deoxygenated blood. This can be done through open-heart surgery or, in some cases, with less invasive techniques.

Surgical Techniques and Technologies

Transcatheter Procedures

These procedures involve inserting a catheter through a small puncture in a blood vessel (usually in the groin or arm) and guiding it to the heart to perform repairs. Examples include Transcatheter Aortic Valve Replacement (TAVR) and Transcatheter Mitral Valve Repair (TMVR).

Transcatheter Aortic Valve Replacement (TAVR)

TAVR is a groundbreaking procedure for patients with severe aortic stenosis who are at high risk for traditional open-heart surgery. A new valve is delivered on a balloon catheter and deployed within the diseased aortic valve. TAVR offers a less invasive option with faster recovery for eligible patients.

Cardiopulmonary Bypass and Myocardial Protection

During open-heart surgery, the cardiopulmonary bypass (CPB) machine is essential. It circulates and oxygenates the blood, allowing the surgeon to operate on a non-beating heart. To protect the heart muscle during this period, cardioplegia solutions are infused into the coronary arteries.
