3. **C - Circulation:** Evaluating haemodynamic stability and controlling haemorrhage. This is arguably the most critical element in battlefield trauma. The manual emphasises aggressive haemorrhage control, including the use of tourniquets, direct pressure, and haemostatic dressings.
4. **D - Disability:** Assessing neurological status using the AVPU scale (Alert, Verbal, Pain, Unresponsive) or the Glasgow Coma Scale (GCS). This helps to identify traumatic brain injuries (TBIs) and other neurological deficits.
5. **E - Exposure and Environment:** Completely exposing the casualty to identify all injuries and to prevent hypothermia. In a battlefield scenario, this also involves considering the environmental factors that might be contributing to the casualty's condition, such as extreme temperatures or exposure to hazardous materials.

The "E" for Exposure also highlights the crucial need to prevent hypothermia, a silent killer that can exacerbate

haemorrhage and impair clotting. The manual stresses the importance of keeping casualties warm, even in challenging conditions.

Haemorrhage Control: The Battlefield Imperative
