On the other hand, an overly decentralized or individualistic approach can lead to doctrinal relativism. If every interpretation is considered equally valid, then the concept of objective truth can be lost, and the church risks becoming a collection of disparate opinions rather than a unified body upholding foundational truths. This can lead to fragmentation and a weakening of the church's witness to the world.

Navigating the right balance between firm conviction and humble openness is a constant challenge.

Maintaining Doctrinal Integrity

Ultimately, the goal for any church is to faithfully transmit the core tenets of the Christian faith as revealed in Scripture, while remaining adaptable to the changing contexts of human experience. This requires a robust understanding of [hermeneutics](#), a commitment to communal discernment, and a reliance on the Holy Spirit. It also necessitates a healthy respect for both Scripture and, for many, the wisdom of historical tradition.
