if ($result->num_rows > 0) {
    // output data of each row
    while($row = $result->fetch_assoc()) {
        echo "id: " . $row["id"]. " - Name: " . $row["Name"]. " - Email: " .
$row["Email"]. "<br>";
    }
} else {
    echo "0 results";
}

$conn->close();
?>

```

Explanation:

1. The `INSERT` query adds a new row to the `users` table.
2. The `SELECT` query retrieves all columns (`id`, `Name`, `Email`) from the `users` table.
3. `\$conn->query(\$sql)` executes the SQL statement.
4. `\$result->num\_rows` checks if any rows were returned.
5. `\$result->fetch\_assoc()` fetches one row at a time as an associative array.
6. We then loop through the results and display the data.

Action: Run `add\_user.php` first, then `view\_users.php` to see the inserted data displayed.
