9. **Axiom of Foundation (or Regularity):** Every non-empty set contains an element that is disjoint from it. This prevents sets from being members of themselves or forming infinite descending chains of membership.
10. **Axiom of Choice (AC):** For any collection of non-empty sets, there exists a choice function that picks out exactly one element from each set. This axiom is controversial for some of its implications but is essential for many fundamental theorems in mathematics.

Sets, Relations, and Functions

Set theory provides the building blocks for defining many other mathematical concepts:

1. **Relations:** A relation between two sets can be defined as a set of ordered pairs. For example, the 'less than'

relation on natural numbers is a set of pairs (a, b) where $a < b$.

2. **Functions:** A function is a special type of relation where each input maps to exactly one output. Functions are formally defined as sets of ordered pairs satisfying this property.
3. **Numbers:** Natural numbers can be constructed from sets. Almost all mathematical proofs implicitly or explicitly rely on the axioms of ZFC and the rules of inference of first-order logic.

Applications Beyond Pure Mathematics

The influence of mathematical logic and set theory extends far beyond pure mathematics:

1. **Computer Science:** Logic is the bedrock of digital circuits, programming languages, and artificial intelligence. Concepts like Boolean logic, propositional logic, and predicate logic are directly applied. Formal verification, model checking, and the theory of computation all draw heavily from logical principles.

1. **Non-classical Logics:** Exploring logics that deviate from classical logic, such as intuitionistic logic (which requires constructive proofs) and modal logic (which deals with notions of necessity and possibility).
2. **Large Cardinals:** Investigating axioms that assert the existence of sets with properties far beyond those guaranteed by ZFC, pushing the boundaries of our understanding of set-theoretic possibility.

3. **Independence Results:** Demonstrating that certain mathematical statements (like the Continuum Hypothesis) cannot be proven or disproven within standard axiomatic systems like ZFC, leading to deeper insights into the structure of mathematical truth.
