It reminds us that even in the darkest of historical moments, the possibility of female agency and power, however mythologized, can offer a beacon of hope and inspiration.

The enduring enigma of Pope Joan, amplified by Carol Ann Duffy's profound and insightful "The Pope," continues to spark debate and inspire critical engagement. It underscores the importance of re-examining historical narratives through a feminist perspective and highlights the power of poetry to give voice to forgotten stories and to challenge the status quo. As long as patriarchy persists, the legend of Pope Joan and Duffy's potent reimagining will undoubtedly continue to resonate, prompting reflection on the past, the present, and the potential for a more just and equitable future.
