For instance, the idea that specific therapeutic gestures can undo deep-seated trauma without robust, trauma-informed evidence can be misleading.

## **4. Certain Forms of "Energy Psychology"**

Approaches like Thought Field Therapy (TFT) or Emotional Freedom Techniques (EFT), while sometimes yielding positive subjective

reports, often operate on theoretical frameworks that are not supported by neurobiological or psychological science. Their proposed mechanisms, such as the manipulation of "energy meridians," are not recognized by mainstream science. While some individuals may find relief through the ritualistic or calming aspects of these techniques, attributing this relief to unsubstantiated energy principles is pseudoscientific. The danger is in promoting these as alternatives to proven therapies for severe conditions.

While largely discredited, the historical pseudoscience of phrenology, which claimed to determine personality traits by measuring bumps on the skull, has modern echoes in certain superficial "neurological assessments" or "brain profiling" systems that lack rigorous validation. These can lead to mischaracterizations and inappropriate interventions.
