$$\cos(a) \approx (0.3420 * 0.1736) + (0.9397 * 0.9848 * -0.1736)$$

$$\cos(a) \approx 0.05935 + (0.9254 * -0.1736)$$

$$\cos(a) \approx 0.05935 - 0.1606$$

$$\cos(a) \approx -0.10125$$

$$a = \arccos(-0.10125) \approx 95.79^\circ$$

Step 2: Find angle B using the Law of Sines.

$$\sin(b)/\sin(B) = \sin(a)/\sin(A)$$

$$\sin(B) = (\sin(b) * \sin(A)) / \sin(a)$$

$$\sin(B) = (\sin(70^\circ) * \sin(100^\circ)) / \sin(95.79^\circ)$$

Using a calculator:

$$\sin(70^\circ) \approx 0.9397$$

$$\sin(100^\circ) \approx 0.9848$$

$$\sin(95.79^\circ) \approx 0.9975$$

$$\sin(B) \approx (0.9397 * 0.9848) / 0.9975$$

$$\sin(B) \approx 0.9254 / 0.9975$$

$$\sin(B) \approx 0.9277$$

$$B = \arcsin(0.9277)$$

Since side b is smaller than side c , angle B should be smaller than angle C . Also, since angle A is obtuse, we need to be careful about the ambiguity in the arcsin function. However, looking at the relative lengths of sides b and c and the known angle A , we can infer the nature of angle B . Given the values, B is likely acute.

$$B \approx 68.06^\circ$$

*(Note: In spherical trigonometry, the arcsin function can yield two possible angles (an acute and an obtuse one).

Careful consideration of the triangle's geometry or other laws is sometimes needed to resolve ambiguity. Here, given side b is less than side a , angle B should be less than angle A . Also, if

We already found $a \approx 95.79^\circ$. Let's find C first using the Law of Cosines for angles, as this avoids the potential ambiguity of the Law of Sines for angles directly:

$\cos(C) = -\cos(A)\cos(B) + \sin(A)\sin(B)\cos(c)$ -- This still needs B.

Let's re-evaluate. After finding a, we can use the Law of Sines for both B and C:

Now, to resolve the ambiguity, we check the sum of angles. The sum of angles must be $> 180^\circ$ and $< 540^\circ$. Let's test the combinations:

1. Case 1: B is acute (68.06°), C is acute (76.42°). Sum = $100^\circ + 68.06^\circ + 76.42^\circ = 244.48^\circ$. This is valid.

4. Case 4: B is obtuse (111.94°), C is obtuse (103.58°). Sum = $100^\circ + 111.94^\circ + 103.58^\circ = 315.52^\circ$. This is valid.

This is where the Law of Cosines for angles becomes invaluable for unique solutions. Let's use it for C, assuming B is acute (68.06°):

$$\cos(C) = (\cos(c) - \cos(a)\cos(b)) / (\sin(a)\sin(b))$$

Problem 2: Solving a Right Spherical Triangle (Given Two Sides)

Problem Statement: In a right spherical triangle ABC, angle C = 90° . Side a = 60° and side b = 75° . Find side c and angles A and B.

Solution Strategy:

Since this is a right spherical triangle, Napier's Rules are our best friends. We'll use the rules involving the given sides to find the unknown parts.

Step 1: Find side c using Napier's Rule.

We have sides a and b, and we want to find hypotenuse c. Looking at Napier's diagram, if we consider c as a middle part, then a and b are opposite parts. The rule is: $\cos(\text{middle part}) = \cos(\text{opposite part 1}) * \cos(\text{opposite part 2})$.

$$\cos(c) = \cos(a)\cos(b)$$

$$\cos(c) = \cos(60^\circ)\cos(75^\circ)$$

$$\cos(60^\circ) = 0.5$$

$$c = \arccos(0.1294) \approx 82.56^\circ$$

Step 2: Find angle A using Napier's Rule.

We have side a and we want angle A . If we consider a as a middle part, then b is an adjacent part, and c is another adjacent part (if we consider the right angle C as part of the sequence). Let's consider angle A as a middle part. Then side b and hypotenuse c are adjacent. However, a more common approach is to consider the sides as middle parts and angles as opposite, or vice-versa. Let's try considering angle A as a middle part. Then side b is adjacent and side c is adjacent. This isn't quite right for a direct rule application. Let's look at the sides and angles again.

Let's use $\sin(a) = \sin(c)\sin(A)$ to find A.

$$\sin(60^\circ) \approx 0.8660$$

$$A = \arcsin(0.8734)$$

Since $a = 60^\circ$ (acute) and $b = 75^\circ$ (acute), and $C = 90^\circ$, both A and B must be acute angles (because if one were obtuse, the sum of angles would be too large or side relationships wouldn't hold for acute sides). So, we take the acute value.

$$A \approx 60.89^\circ$$

Step 3: Find angle B using Napier's Rule.

We can use $\sin(b) = \sin(c)\sin(B)$.

$$\sin(B) = \sin(b) / \sin(c)$$

$$\sin(B) = \sin(75^\circ) / \sin(82.56^\circ)$$

$$\sin(75^\circ) \approx 0.9659$$

$$\sin(B) \approx 0.9659 / 0.9915 \approx 0.9742$$

$$B = \arcsin(0.9742)$$

Taking the acute value:

$$B \approx 76.91^\circ$$

Check: Sum of angles.

$$A \approx 60.89^\circ$$

$$B \approx 76.91^\circ$$

$$C = 90^\circ$$

$$\text{Sum} = 60.89^\circ + 76.91^\circ + 90^\circ = 227.8^\circ. \text{ This is valid.}$$

Final Answer for Problem 2:

$$\text{Side } c \approx 82.56^\circ$$

$$\text{Angle } A \approx 60.89^\circ$$

$$\text{Angle } B \approx 76.91^\circ$$

Problem 3: Navigational Application - Finding Distance Between Two Points

Problem Statement: Calculate the great-circle distance between two cities: City X at latitude 30° N, longitude 45° E and City Y at latitude 60° S, longitude 120° W. Assume the Earth's radius is 6371 km.

Solution Strategy:

This problem can be modeled as finding the length of side 'a' of a spherical triangle formed by the North Pole (NP), City X, and City Y. The sides of this triangle will be arcs of great circles.

Let NP be point P.

1. Side p (opposite P, i.e., the distance between X and Y) is what we want to find.
2. Side x (opposite X) is the colatitude of City Y.
3. Side y (opposite Y) is the colatitude of City X.
4. Angle P (at the North Pole) is the difference in longitudes between X and Y.

Step 1: Determine the sides of the spherical triangle in degrees.

Latitude 30° N means the angle from the equator is 30° .

Colatitude (distance from the pole) is $90^\circ - \text{Latitude}$.

Latitude of City X = 30° N. So, side $y = 90^\circ - 30^\circ = 60^\circ$.

Latitude of City Y = 60° S. So, side $x = 90^\circ - (-60^\circ) = 150^\circ$ (since South latitude is negative, its distance from the North Pole is greater).

Step 2: Determine the angle at the North Pole (P).

Longitude of City X = 45° E.

Longitude of City Y = 120° W.

The difference in longitudes is $45^\circ + 120^\circ = 165^\circ$ (we add because they are on opposite sides of the prime meridian).

So, angle $P = 165^\circ$.

Step 3: Use the Law of Cosines (for sides) to find side p (the distance in degrees).

$$\cos(p) = \cos(x)\cos(y) + \sin(x)\sin(y)\cos(P)$$

$$\cos(p) = \cos(150^\circ)\cos(60^\circ) + \sin(150^\circ)\sin(60^\circ)\cos(165^\circ)$$

Using a calculator:

$$\cos(150^\circ) \approx -0.8660$$

$$\cos(60^\circ) = 0.5$$

$$\sin(150^\circ) = 0.5$$

$$\sin(60^\circ) \approx 0.8660$$

$$\cos(165^\circ) \approx -0.9659$$

$$\cos(p) \approx (-0.8660 * 0.5) + (0.5 * 0.8660 * -0.9659)$$

$$\cos(p) \approx -0.4330 + (0.4330 * -0.9659)$$

$$B = \arccos(0.5176) \approx 58.83^\circ$$

And for angle C :

$$\cos(C) = (\cos(c) - \cos(a) \cos(b)) / (\sin(a) \sin(b))$$

$$\cos(C) = (\cos(75^\circ) - \cos(90^\circ) \cos(60^\circ)) / (\sin(90^\circ) \sin(60^\circ))$$

$$\cos(C) = (0.2588 - 0 * 0.5) / (1 * 0.8660)$$

$$\cos(C) = 0.2588 / 0.8660 \approx 0.2988$$

$$C = \arccos(0.2988) \approx 72.63^\circ$$

Verification: $A + B + C = 98.92^\circ + 58.83^\circ + 72.63^\circ = 230.38^\circ$. The sum is greater than 180° .

$$\cos(c2) = \cos(50^\circ) \cos(70^\circ) + \sin(50^\circ) \sin(70^\circ) \cos(127.96^\circ)$$

$$\cos(c2) = (0.6428) * (0.3420) + (0.7660) * (0.9397) * (-0.6151)$$

$$\cos(c2) = 0.2199 - 0.7200 * 0.6151$$

$$\cos(c2) = 0.2199 - 0.4430 = -0.2231$$

$$c2 = \arccos(-0.2231) \approx 102.91^\circ$$

Now find C2 using the Law of Cosines for angles:

$$\cos(C2) = (\cos(c2) - \cos(a) \cos(b)) / (\sin(a) \sin(b))$$

$$\begin{aligned}\cos(C2) &= (\cos(102.91^\circ) - \cos(50^\circ) \cos(70^\circ)) / (\sin(50^\circ) \\ &\sin(70^\circ))\end{aligned}$$

$$\cos(C2) = (-0.2233 - 0.2199) / (0.7199)$$

$$\cos(C2) = -0.4432 / 0.7199 \approx -0.6156$$

$$C2 = \arccos(-0.6156) \approx 128.03^\circ$$

Check: $A + B_2 + C_2 = 40^\circ + 127.96^\circ + 128.03^\circ = 295.99^\circ$.
This sum is greater than 180° , making this a valid spherical triangle.

Therefore, in this SSA case, only $B_2 = 127.96^\circ$ is a valid solution.
