In a class of 30 students, 15 like science, 10 like math, and 5 like both science and math. What is the probability that a randomly selected student likes science OR math?

Answer and Explanation:

Liking science and liking math are not mutually exclusive because some students like both.

Probability of liking science: $P(\text{Science}) = 15/30$

Probability of liking math: $P(\text{Math}) = 10/30$

Probability of liking both science and math:
 $P(\text{Science and Math}) = 5/30$

Probability of liking science or math: $P(\text{Science or Math}) = P(\text{Science}) + P(\text{Math}) - P(\text{Science and Math})$
 $= (15/30) + (10/30) - (5/30) = 20/30 = 2/3$

3. $P(\text{Test is positive} \mid D) = 0.95$ (Probability test identifies a defective bulb as defective - True Positive Rate)
4. $P(\text{Test is negative} \mid D') = 0.90$ (Probability test identifies a non-defective bulb as non-defective - True Negative Rate)

From the given information, we can derive:

1. $P(\text{Test is negative} \mid D) = 1 - P(\text{Test is positive} \mid D) = 1 - 0.95 = 0.05$ (False Negative Rate)
2. $P(\text{Test is positive} \mid D') = 1 - P(\text{Test is negative} \mid D') = 1 - 0.90 = 0.10$ (False Positive Rate)

We want to find $P(D \mid \text{Test is negative})$. Using Bayes' Theorem:

This counterintuitive result highlights how a highly accurate test can still produce a low probability of a bulb being defective if the base rate of defects is very low.

5. Permutations and Combinations in Probability

In scenarios where the order of selection matters (permutations) or doesn't matter (combinations), these concepts become vital for calculating the number of possible outcomes.

Example Question:

A committee of 3 people is to be chosen from a group of 10. How many different committees can be formed? What is the probability that a specific group of 3 people is chosen?

Answer and Explanation:

Since the order in which the committee members are

chosen does not matter, we use combinations.

The formula for combinations is $C(n, k) = n! / (k! * (n-k)!)$, where n is the total number of items, and k is the number of items to choose.

Number of different committees:

$$n = 10, k = 3$$

$$C(10, 3) = 10! / (3! * (10-3)!) = 10! / (3! * 7!) = (10 * 9 * 8) / (3 * 2 * 1) = 720 / 6 = 120$$

There are 120 possible committees.

Probability of a specific group of 3 people being chosen:

There is only 1 specific group of 3 people we are interested in.

Probability: $1 / 120$
