However, the historical significance of ICD-9 codes, particularly for analyzing long-term trends and understanding past research, ensures that knowledge of codes like 335.20 continues to be relevant. As the medical field advances, so too do the tools we use to classify and understand diseases, ultimately aiming for better care, more targeted research, and improved outcomes for those affected by conditions like ALS.
