Here, y is the dependent variable, $x_1, x_2, \dots, x_p$ are the independent variables, $\beta_0, \beta_1, \dots, \beta_p$ are the model coefficients (parameters) we aim to estimate, and ϵ is the random error term, typically assumed to be normally distributed with a mean of zero.

When we move beyond a single observation and consider a dataset of n observations, this equation needs to be represented in a more compact and computationally efficient way. This is where matrices come into play.

2. Matrix Addition and Subtraction

These operations are straightforward and apply to matrices of the same dimensions. In the context of linear models, they might be used for comparing different model fits or for manipulating residuals.

3. Matrix Multiplication ($\mathbf{AB}$)

This is a more complex operation, but its importance cannot be overstated. For the product $\mathbf{AB}$ to be defined, the number of columns in $\mathbf{A}$ must equal the number of rows in $\mathbf{B}$. The most common method for estimating the coefficients β in a linear model is Ordinary Least Squares (OLS). OLS aims to minimize the sum of squared errors (SSE). Mathematically, this is expressed as:

$$SSE = \epsilon^T \epsilon = (y - X\beta)^T (y - X\beta)$$

To find the value of β that minimizes SSE, we take the derivative of SSE with respect to β and set it to zero. This is where matrix calculus and algebra shine. The derivation leads to the famous **normal equations**:

$$(X^T X) \beta = X^T y$$

In matrix terms, this often manifests as the $X^T X$ matrix becoming close to singular, meaning its determinant is very small. This makes the inverse $(X^T X)^{-1}$ unstable and difficult to compute reliably, leading to large standard errors for the coefficient estimates and unreliable interpretations.

Rank deficiency occurs when one or more predictor variables can be perfectly predicted by others. This leads to $X^T X$ being singular (determinant is zero), meaning it is not invertible, and a unique OLS solution cannot be found. Techniques like principal component regression or ridge regression, which have roots in matrix algebra, are employed to handle these situations.

Beyond OLS: Other Linear Model Frameworks

While OLS is the most common estimation method, matrix algebra is fundamental to other linear model frameworks as well:

1. Generalized Least Squares (GLS)

When the error terms are not independent or have unequal variances (heteroskedasticity), GLS is used. The GLS estimator, which is more efficient than OLS in such cases, is given by:
