of basic infrastructure might see significant growth benefits from government investments in public education and healthcare, even if it means a temporary increase in the size of the state. Conversely, a highly developed nation with already robust public services might find that further expansions of government lead to diminishing returns or even negative consequences due to increased inefficiency or tax burdens.
