4. **Reasoning with Equations and Inequalities:** Mastering advanced techniques for solving systems of equations and inequalities, and understanding the properties of solutions.
5. **Functions:** Exploring polynomial, rational, radical, exponential, logarithmic, and trigonometric functions. This includes understanding their graphs, transformations, inverses, and applications.
6. **Interpreting Functions:** Analyzing function behavior, including domain, range, symmetry, end behavior, and periodicity.
7. **Building Functions:** Constructing and composing functions to model real-world phenomena.
8. **Linear, Quadratic, and Exponential Models:** Recognizing and applying these functional models to describe patterns and make predictions.
9. **Trigonometry:** Understanding trigonometric functions, their graphs, identities, and applications in geometry and beyond.
10. **Statistics and Probability:** Extending statistical reasoning, including analyzing bivariate data, probability distributions, and inferential statistics.

Effective Algebra II Common Core lesson plans are designed to weave these concepts together, promoting coherence and a deep understanding of how different algebraic ideas are interconnected. The emphasis is on "doing mathematics" – engaging in the Standards for Mathematical Practice (SMPs) rather than just memorizing procedures.

5. Active Student Engagement and Practice

Students learn best by doing. Lesson plans must include ample opportunities for students to actively apply what they've learned. This can take many forms:
