Leeson, based in Singapore, engaged in unauthorized speculative trading, racking up massive losses that ultimately exceeded the bank's capital reserves. The scandal exposed the critical importance of robust internal controls and risk management practices. This case study underscores the devastating consequences of failing to adequately assess and manage operational risk. While rogue traders are less common today, the core lessons remain relevant: organizations must implement rigorous processes and oversight to prevent similar scenarios.

They are not direct measures of loss, but rather indicators that, if they move beyond a certain threshold, suggest a higher probability of a future loss event. Examples include employee turnover rates, system uptime percentages, the number of failed transactions, or the volume of customer complaints. Effective KRIs are predictive, measurable, and actionable.
4. **Factor-Based Models:** These models attempt to link operational risk to underlying business activities and their associated drivers. For example, the volume of transactions processed, the complexity of products offered, or the number of new markets entered could be considered drivers of operational risk. By understanding these relationships, organizations can better anticipate how changes in their business activities might impact their operational risk profile.

The goal of operational risk modeling is not to produce a single, definitive number. Instead, it's about creating a range of potential outcomes, understanding the drivers of these outcomes, and using this information to inform decision-making. This often involves sophisticated statistical techniques and software, but the foundational principles are about understanding patterns, probabilities, and potential impacts.
