- Consider the Domain of  $f(x)$ :** It's essential to remember the original domain of  $f(x)$ . If the algebraic process yields a set of possible  $y$  values, you must ensure that for each of these  $y$  values, there exists a corresponding  $x$  within the \*original domain\* of  $f(x)$ .

## Finding the Range of Linear Functions

Linear functions are the simplest to analyze. A linear function is of the form  $f(x) = mx + b$ , where  $m$  and  $b$  are constants and  $m \neq 0$ . For such functions, there are no inherent restrictions on the input  $x$  (unless specified), so the domain is all real numbers. Let's find the range algebraically:

- Let  $y = mx + b$ .
- Isolate  $x$ :  $y - b = mx$   $x = \frac{y - b}{m}$
- Restrictions on  $y$ : Since  $m$  is a non-zero constant, the denominator is never zero. There are no other terms in the expression for  $x$  that would introduce restrictions on  $y$ .

Therefore, for a non-constant linear function, the range is all real numbers, often denoted as  $(-\infty, \infty)$  or  $\mathbb{R}$ .

## Finding the Range of Quadratic Functions

Quadratic functions, typically in the form  $f(x) = ax^2 + bx + c$  where  $a \neq 0$ , are a common source of range-finding exercises. Their graphs are parabolas, which either open upwards or downwards, indicating a minimum or maximum output value, respectively. This extremum is key to determining the range.

### Method 1: Completing the Square

This method transforms the quadratic into vertex form,  $f(x) = a(x - h)^2 + k$ , where  $(h, k)$  is the vertex of the parabola.

**Example:** Find the range of  $f(x) = x^2 - 4x + 3$ .

- Let  $y = x^2 - 4x + 3$ .
- Complete the square:  $y = (x^2 - 4x + 4) - 4 + 3$   $y = (x - 2)^2 - 1$
- Analyze the structure: The term  $(x - 2)^2$  is always non-negative, meaning  $(x - 2)^2 \geq 0$ .
- Determine the minimum/maximum:  $y = (x - 2)^2 - 1 \geq 0 - 1$   $y \geq -1$



Since the coefficient of  $(x^2)$  (which is 1 in this case) is positive, the parabola opens upwards, and  $(y = -1)$  is the minimum value. Thus, the range is  $[-1, \infty)$ .

## Method 2: Using the Discriminant (for $(y = ax^2 + bx + c)$ )

This method involves treating the equation  $(y = ax^2 + bx + c)$  as a quadratic equation in  $(x)$  and using the discriminant  $(\Delta = b^2 - 4ac)$  to find the values of  $(y)$  for which real solutions for  $(x)$  exist.

1. Rearrange the equation into a standard quadratic form in  $(x)$ :  $(ax^2 + bx + (c - y) = 0)$
2. For real solutions of  $(x)$  to exist, the discriminant of this quadratic in  $(x)$  must be greater than or equal to zero:  $(b^2 - 4a(c - y) \geq 0)$
3. Solve this inequality for  $(y)$ .

**Example:** Find the range of  $(f(x) = -2x^2 + 8x - 5)$ .

1. Let  $(y = -2x^2 + 8x - 5)$ .
2. Rearrange:  $(2x^2 - 8x + (5 + y) = 0)$ . (Multiplying by -1 and rearranging).
3. Apply the discriminant condition: Here, the quadratic in  $(x)$  is  $(2x^2 - 8x + (5 + y) = 0)$ . The coefficients are  $(A = 2)$ ,  $(B = -8)$ , and  $(C = (5 + y))$ .  $(\Delta = B^2 - 4AC \geq 0)$   $((-8)^2 - 4(2)(5 + y) \geq 0)$   $(64 - 8(5 + y) \geq 0)$   $(64 - 40 - 8y \geq 0)$   $(24 - 8y \geq 0)$   $(24 \geq 8y)$   $(3 \geq y)$   $(y \leq 3)$

Since the coefficient of  $(x^2)$  in the original function  $(-2)$  is negative, the parabola opens downwards, and  $(y = 3)$  is the maximum value. The range is  $((-\infty, 3])$ .

## Finding the Range of Rational Functions

Rational functions are ratios of two polynomials,  $(f(x) = \frac{P(x)}{Q(x)})$ . Finding their range often involves identifying horizontal asymptotes and holes in the graph, and then using algebraic manipulation to determine the achievable  $(y)$  values.

**Example:** Find the range of  $(f(x) = \frac{x}{x - 1})$ .

1. Let  $(y = \frac{x}{x - 1})$ .
2. Isolate  $(x)$ :  $(y(x - 1) = x)$   $(xy - y = x)$   $(xy - x = y)$   $(x(y - 1) = y)$   $(x = \frac{y}{y - 1})$
3. Determine restrictions on  $(y)$ : The expression for  $(x)$  is undefined when the denominator is zero, i.e., when  $(y - 1 = 0)$ , which means  $(y = 1)$ .

This indicates that  $(y = 1)$  is a value that the function can never attain. This corresponds to the horizontal asymptote of the function. The range is all real numbers except 1, which can be written as  $((-\infty, 1) \cup (1, \infty))$ .

**Important Note:** For rational functions, always consider the domain restrictions first. In this case,  $(x \neq 1)$ . The value  $(y=1)$  is not achievable because it would require  $(x)$  to be infinite, which is not a real number. We also need to check if any specific values of  $(y)$  lead to an  $(x)$  that is \*outside\* the original domain. However, in this example, all derived  $(y)$  values lead to valid  $(x)$  values as long as  $(y \neq 1)$ .

## Finding the Range of Functions with Square Roots

Functions involving square roots, like  $(f(x) = \sqrt{g(x)})$ , have inherent restrictions due to the fact that the radicand (the expression inside the square root) must be non-negative. The output of a square root function is also always non-negative.

**Example:** Find the range of  $(f(x) = \sqrt{x - 2})$ .

1. First, determine the domain: The expression inside the square root must be non-negative.  $(x - 2 \geq 0)$  implies  $(x \geq 2)$ . The domain is  $[2, \infty)$ .
2. Let  $(y = \sqrt{x - 2})$ .
3. Isolate  $(x)$ :  $(y^2 = x - 2)$   $(x = y^2 + 2)$

4. Consider the nature of the square root: By definition, the principal square root ( $\sqrt{\cdot}$ ) yields a non-negative result. Therefore,  $y \geq 0$ .
5. Combine with the domain: We found that  $x = y^2 + 2$ . For any  $y \geq 0$ , the corresponding  $x$  will be  $x \geq 0^2 + 2 = 2$ , which is within our domain.

Thus, the range of  $f(x) = \sqrt{x - 2}$  is  $[0, \infty)$ .

**Example 2:** Find the range of  $f(x) = 3 - \sqrt{x}$ .

1. Domain:  $x \geq 0$ .
2. Let  $y = 3 - \sqrt{x}$ .
3. Analyze the square root term: We know  $\sqrt{x} \geq 0$ .
4. Consider the effect of the negative sign and subtraction:  $\sqrt{x} \geq 0 \implies -\sqrt{x} \leq 0 \implies 3 - \sqrt{x} \leq 3 + 0 \implies y \leq 3$

The range is  $(-\infty, 3]$ . We also need to ensure that for every  $y \leq 3$ , there exists a valid  $x \geq 0$ . If  $y \leq 3$ , then  $3 - y \geq 0$ . So  $\sqrt{x} = 3 - y$ . Squaring both sides gives  $x = (3 - y)^2$ . Since  $3 - y \geq 0$ ,  $x = (3 - y)^2 \geq 0$ , which is within the domain.

## Finding the Range of Exponential and Logarithmic Functions

Exponential functions of the form  $f(x) = a^x$  (where  $a > 0$  and  $a \neq 1$ ) have a range of  $(0, \infty)$  because exponential values are always positive. Transformations can shift or stretch this range.

Logarithmic functions of the form  $f(x) = \log_b(x)$  (where  $b > 0$  and  $b \neq 1$ ) have a range of  $(-\infty, \infty)$  because any real number can be an exponent.

**Example:** Find the range of  $f(x) = 2^x + 1$ .

1. We know that  $2^x > 0$  for all real  $x$ .
2. Adding 1 to both sides:  $2^x + 1 > 0 + 1$ , so  $f(x) > 1$ .

The range is  $(1, \infty)$ .

**Example:** Find the range of  $f(x) = \ln(x - 3)$ .

1. Domain:  $x - 3 > 0 \implies x > 3$ .
2. Let  $y = \ln(x - 3)$ .
3. To find the range, we can express  $x$  in terms of  $y$ :  $e^y = x - 3 \implies x = e^y + 3$
4. Consider the nature of  $(e^y)$ :  $(e^y)$  can take any positive value.
5. Thus,  $x = e^y + 3$  can take any value greater than 3, which aligns with our domain.

Since  $(e^y)$  can be any positive real number,  $y$  can also be any real number. The range is  $(-\infty, \infty)$ .
