However, his satire is not merely destructive; it is, as he explicitly states in his preface, intended for "the Service of Mankind." He targets hypocrisy, pretension, pride, and the abuse of power, all of which he sees as corrupting influences on society. The novel critiques the fashionable world of London, with its superficial manners and its insincere social interactions, as well as the rural gentry, who often display a similar blend of arrogance and ignorance. Fielding's satire aims to provoke laughter, yes, but also to encourage self-reflection and to promote a more virtuous and compassionate way of living. He is particularly keen to distinguish between genuine goodness, exemplified by Joseph and Parson Adams, and its outward imitation, which he views as morally bankrupt.
