While diatonic common chords are the bedrock, composers can also employ chords with a degree of chromaticism to facilitate modulation. One powerful technique involves using **secondary dominants** as pivot chords. A secondary dominant is the dominant chord of a chord other than the tonic. These chords, while not strictly diatonic to the original key, often appear in more complex harmonic writing and can serve as effective bridges.

Example 3: Modulating from C Major to A Minor using E7

Let's aim to modulate from C Major to its relative minor, A Minor. The diatonic chords in C Major are C, Dm, Em, F, G, Am, Bdim. The diatonic chords in A Minor are Am, Bdim, C, Dm, Em, F, G.

Consider a progression ending in C Major: **F - G - C**. The G chord is the V of C.

Now, let's introduce a modulation to A Minor. The dominant chord of A Minor is E Major (or E7). While E Major isn't diatonic to C Major, it's a common passing chord. Importantly, E7 is the V7 of Am. The chord E7 is also the V7 of Am. The pivot chord here is not a shared diatonic chord in the strictest sense, but rather a chord that strongly leads to the tonic of the new key, and has a relationship with the original key.

A more common and elegant use of a secondary dominant as a pivot involves a chord that *is* diatonic to the original key and *also* has its own secondary dominant leading to the new tonic.

Let's refine: Consider modulating from C Major to D Minor. The diatonic chords in C Major are C, Dm, Em, F, G, Am, Bdim. The diatonic chords in D Minor are Dm, Edim, F, Gm, Am, Bb, C.

A common chord here is F. In C Major, F is the IV chord. In D Minor, F is the III chord.

However, the dominant of D Minor is A7. To use common chord modulation effectively, we can use a chord that is shared and *also* has a strong pull towards the new key. Consider this:

C (I in C) - G/B (V6 in C) - Am (vi in C)

Now, let's use the Am chord as a pivot to modulate to D Minor. In D Minor, Am is the v chord (minor dominant). This isn't a strong pull. A more effective pivot is often a chord that *can* be interpreted as having a dominant function in the new key.

Let's try a different example for secondary dominants. Modulating from C Major to E Minor.

C Major Chords: C, Dm, Em, F, G, Am, Bdim

E Minor Chords: Em, F#dim, G, Am, B7, C, D

Shared Diatonic Chords: Em, G, Am, C.

Consider: **C (I in C) - Am (vi in C) - G (V in C) - C (I in C)**

To modulate to E Minor, we can use the Am chord as a pivot. In E Minor, Am is the iv chord. This is a relatively weak harmonic movement. A stronger pivot involves using the dominant of the new key as the connecting element.

Here's a more sophisticated common chord modulation using chromaticism and secondary dominants, often seen in jazz and classical music:

C Major (I) - G/B (V6) - Am (vi)

Now, we want to modulate to E Minor. The dominant of E Minor is B7. Notice that B7 is not diatonic to C Major. However, let's consider the Am chord. In C Major, it's vi. In E Minor, it's iv. We can precede Am with a chord that sets up the modulation to E Minor.

Consider this: **C (I in C) - F (IV in C) - Bdim (vii° in C) - E7 (V7 in A minor)**

This is not strictly common chord modulation but rather a direct modulation using a secondary dominant. A true common chord modulation would use a chord that belongs to **both** keys. Let's return to the power of diatonic chords.

The beauty of common chord modulation is its subtlety. It's not about introducing a foreign chord and then resolving it, but about reinterpreting a chord that already exists in the sonic landscape. The secondary dominant technique is more about **leading** to a chord that **will** be in the new key, but isn't necessarily a shared chord itself in the initial context.

Let's revisit the C Major to G Major modulation with a slightly more complex example, demonstrating how even a brief chromatic alteration can still be considered common chord modulation if the pivot is understood in both contexts:

C (I) - Dm (ii) - G (V) - C (I)

To modulate to G Major, we can use the G chord as a pivot. In C Major, it's V. In G Major, it's I. This is a very direct and common modulation. Now, let's incorporate a chord that bridges more subtly.

Consider: **C (I) - Em (iii) - Am (vi) - D7 (V7 in G) - G (I in G)**

Here, the Am chord is diatonic to both C Major (vi) and G Major (ii). The D7 is the V7 of G Major. The preceding Am smoothly prepares the listener for the dominant of G Major.

Common Modulatory Patterns and Their Applications

Several common modulatory patterns emerge from the principles of common chord modulation, each with its own flavor and suitability for different musical contexts. These

patterns are often seen in popular music, classical compositions, and even film scores.

1. Modulation to the Dominant (V)

This is perhaps the most frequent type of modulation. As seen in the C Major to G Major example, the V chord of the original key often serves as the pivot, becoming the I chord of the new key. This creates a sense of ascent and forward motion.

2. Modulation to the Subdominant (IV)

Modulating to the IV chord, as demonstrated with C Major to F Major, offers a sense of relaxation and grounding. The IV chord of the original key becomes the I chord of the new key.

3. Modulation to the Relative Major/Minor

This is an extremely smooth and natural modulation because the relative major and minor keys share all the same diatonic chords. For example, modulating between C Major and A Minor is seamless. Any chord in C Major is also diatonic to A Minor, and vice versa. The trick is in re-contextualizing these shared chords to establish the new tonic.

4. Modulation by a Major Third (Up or Down)

This type of modulation, while seemingly more distant, can be effectively achieved using common chords, particularly in more complex jazz harmonies. For instance, moving from C Major to E Major involves a significant harmonic shift. However, common tones and carefully chosen pivot chords can bridge this gap. The relationship between the mediant (iii) of one key and the tonic of another, or the submediant (vi) and the tonic, can be exploited.

Practical Tips for Using Common Chord Modulation

Mastering common chord modulation involves more than just theoretical understanding; it requires practical application and a keen ear. Here are some tips for effectively incorporating this technique into your music:

1. **Know Your Scales and Chords:** A solid grasp of key signatures, diatonic chords, and their functions is paramount. Understanding the relationships between keys is essential for identifying potential pivot chords.
2. **Listen for Common Tones:** Even if a chord isn't perfectly diatonic to both keys, if it shares significant common tones with chords in both the original and target keys, it can act as a pivot.
3. **Emphasize the New Tonic:** Once the pivot chord is played, ensure that the subsequent chords strongly establish the new key. A clear V-I cadence in the new key is crucial for solidifying the modulation.
4. **Consider the Context:** The emotional impact of a modulation depends on the surrounding music. A modulation that feels smooth in a ballad might feel abrupt in an upbeat pop song.
5. **Experiment and Listen:** The best way to learn is by doing. Experiment with different pivot chords and observe how they affect the overall mood and flow of your music. Record your

ideas and listen back critically.

6. **Use Chord Progressions You Know:** Start by modulating between keys that are closely related (e.g., dominant, subdominant, relative major/minor). As you gain confidence, explore more distant modulations.
