The traditional "dicots" are now understood to be paraphyletic, meaning they do not include all descendants of a common ancestor. The basal angiosperms, an ancient lineage predating the split of monocots and eudicots, also represent a distinct evolutionary branch. Furthermore, the dicots have been largely refined into a monophyletic group called eudicots, which encompasses the majority of flowering plants traditionally considered dicots. The remaining former dicots are now grouped into several smaller, distinct evolutionary lineages.

This evolving understanding of angiosperm phylogeny highlights the dynamic nature of botanical classification. While the monocot-eudicot division remains a useful starting point for understanding broad patterns of diversity, a deeper appreciation requires acknowledging these more ancient lineages and the refined eudicot group. Within these major clades, the families represent the next significant level of evolutionary divergence.
