Solving these equations, often with initial conditions, reveals the system's response over time, including transient behavior and steady-state values.

## Difference Equations: The Discrete Steps

For systems that operate in discrete time steps (common in digital control and signal processing), linear difference equations are used:

$$a_n y[k+n] + a_{n-1} y[k+n-1] + \dots + a_0 y[k] = b_m u[k+m] + b_{m-1} u[k+m-1] + \dots + b_0 u[k]$$

Here,  $y[k]$  and  $u[k]$  represent the output and input at time step  $k$ . Solutions to these equations describe how the system's state changes from one discrete instant to the next.

$$F(s) = \mathcal{L}\{f(t)\} = \int_0^{\infty} f(t) e^{-st} dt$$

The ratio of the Laplace transform of the output to the Laplace transform of the input, assuming zero initial conditions, is known as the **transfer function**,  $G(s)$ :

$$G(s) = \frac{Y(s)}{U(s)}$$

The transfer function is a concise representation of the system's input-output relationship and its poles and zeros (roots of the denominator and numerator polynomials, respectively) reveal crucial information about stability and transient response.

## The Fourier Transform: Decomposing Signals

The Fourier transform of a function  $f(t)$  is defined as:
