2. **Rewrite the expression:** $[6x(x + 2)] / (3x)$
3. **Identify common factors:** We see 'x' as a common factor in both the numerator and the denominator. We also see that 6 in the numerator and 3 in the denominator share a common factor of 3.
4. **Cancel common factors:** We can divide both $6x$ by $3x$, which leaves 2.
5. **Simplified expression:** $2(x + 2)$ or $2x + 4$.

Important Note: Always remember to consider the domain of the original expression. In this case, x cannot be 0 because it would make the denominator zero. The simplified expression $2(x + 2)$ is equivalent to the original expression only for $x \neq 0$.

Factoring Quadratic Expressions (Trinomials)

Quadratic expressions of the form $ax^2 + bx + c$ are frequently encountered. The goal is to find two binomials whose product equals the trinomial. This often involves finding two numbers that multiply to 'ac' and add up to 'b' (when $a=1$) or using more advanced grouping methods.

Example 2: Simplifying a Quadratic Expression

Simplify: $(x^2 + 5x + 6) / (x^2 + 7x + 10)$

1. **Factor the numerator:** We need two numbers that multiply to 6 and add to 5. These numbers are 2 and 3. So, $x^2 + 5x + 6 = (x + 2)(x + 3)$.
2. **Factor the denominator:** We need two numbers that multiply to 10 and add to 7. These numbers are 2 and 5. So, $x^2 + 7x + 10 = (x + 2)(x + 5)$.
3. **Rewrite the expression:** $[(x + 2)(x + 3)] / [(x + 2)(x + 5)]$
4. **Identify and cancel common factors:** The common factor is $(x + 2)$.

Factoring the Difference of Squares

Expressions in the form $a^2 - b^2$ can be factored into $(a - b)(a + b)$. This is a powerful pattern to recognize.

Example 3: Simplifying with Difference of Squares

Simplify: $(x^2 - 9) / (x^2 - 4x + 3)$

1. **Factor the numerator:** This is a difference of squares $(x^2 - 3^2)$. So, $x^2 - 9 = (x - 3)(x + 3)$.
2. **Factor the denominator:** We need two numbers that multiply to 3 and add to -4 . These numbers are -1 and -3 . So, $x^2 - 4x + 3 = (x - 1)(x - 3)$.
3. **Rewrite the expression:** $[(x - 3)(x + 3)] / [(x - 1)(x - 3)]$
4. **Identify and cancel common factors:** The common factor is $(x - 3)$.
5. **Simplified expression:** $(x + 3) / (x - 1)$.

The restrictions here are $x \neq 1$ and $x \neq 3$.

Factoring by Grouping

This technique is useful for polynomials with four terms, where you group terms in pairs to find common factors.

Example 4: Simplifying with Factoring by Grouping

Simplify: $(x^3 + 2x^2 - 4x - 8) / (x^2 - 4)$

1. **Factor the numerator by grouping:**
 1. Group the first two terms: $x^2(x + 2)$
 2. Group the last two terms: $-4(x + 2)$

3. Combine: $(x^2 - 4)(x + 2)$
2. **Factor the denominator:** This is a difference of squares: $(x - 2)(x + 2)$.
3. **Rewrite the expression:** $[(x^2 - 4)(x + 2)] / [(x - 2)(x + 2)]$
4. **Identify and cancel common factors:** The common factor is $(x + 2)$. We also notice that $(x^2 - 4)$ is a difference of squares that can be factored further into $(x - 2)(x + 2)$. So the expression becomes $[(x - 2)(x + 2)(x + 2)] / [(x - 2)(x + 2)]$.
5. **Cancel all common factors:** We can cancel $(x - 2)$ and $(x + 2)$.
6. **Simplified expression:** $(x + 2)$.

The values of x that make the original denominator zero are $x = 2$ and $x = -2$.

Handling Special Cases and Potential Pitfalls

While factoring is the primary tool, several situations require extra attention.

Expressions with Negative Signs

When factoring, be mindful of negative signs. Sometimes, a factor might appear as $(a - b)$ in one part of the expression and $(b - a)$ in another. Remember that $(b - a) = -1 * (a - b)$. You can factor out a -1 to make the terms match, allowing for cancellation.

Example 5: Managing Negative Signs

Simplify: $(x - 5) / (10 - 2x)$

1. **Factor the denominator:** The greatest common factor of 10 and $-2x$ is -2 . So, $10 - 2x = -2(x - 5)$.
2. **Rewrite the expression:** $(x - 5) / [-2(x - 5)]$
3. **Identify and cancel common factors:** The common factor is $(x - 5)$.
4. **Simplified expression:** $1 / -2$, or $-1/2$.

Here, x cannot be 5.

When No Simplification is Possible

Not all rational expressions can be simplified. If, after attempting all factoring techniques, you find no common factors between the numerator and the denominator, the expression is already in its simplest form.

Example 6: An Unsimplifiable Expression

Consider: $(x^2 + 2x + 1) / (x + 3)$

The numerator factors into $(x + 1)(x + 1)$. The denominator is already a linear expression. There are no common factors between $(x + 1)(x + 1)$ and $(x + 3)$. Therefore, this expression cannot be simplified further.

The Importance of Domain Restrictions

It's paramount to remember that when simplifying rational expressions, the simplified expression is equivalent to the original expression **only** for values of the variable that do not make the **original** denominator zero. These are called **domain restrictions**.

For example, in the simplification of $(x^2 + 5x + 6) / (x^2 + 7x + 10)$ to $(x + 3) / (x + 5)$, the original denominator $(x^2 + 7x + 10)$ is zero when $x = -2$ or $x = -5$. Therefore, the simplified expression is valid for all x except $x = -2$ and $x = -5$.

In many contexts, you will be asked to state these restrictions along with the simplified expression. This is a crucial part of understanding the behavior and equivalence of algebraic expressions.
