This balancing act was evident in Mexico's refusal to fully commit to U.S. military alliances until after the attack on Pearl Harbor. While cooperating on intelligence sharing and defense matters, Mexico was careful not to be drawn into conflicts that did not directly threaten its own interests. The expropriation of oil, while a point of contention with the U.S., was also a clear signal to both European powers and the United States that Mexico would not be a passive player in its own destiny. This assertion of national control over resources was a key component of its foreign policy independence.

The internal political landscape also played a role. Mexico was still a relatively young nation, consolidating its post-revolutionary identity. Foreign policy decisions had to be carefully calibrated to avoid alienating powerful domestic constituencies or undermining the revolutionary project. The government sought to portray its foreign policy as one of principled neutrality and self-determination, a stance that resonated with a population that had a deep-seated suspicion of foreign intervention. The notion of Mexican exceptionalism, of charting its own course, was a powerful force in shaping its international relations.

The Turning Tide: From Neutrality to War

The attack on Pearl Harbor on December 7, 1941, irrevocably altered the global landscape and Mexico's place within it. This direct assault on U.S. soil galvanized American public opinion and led to a swift declaration of war. For Mexico, the decision became much clearer. The Axis powers were now a direct threat to the entire hemisphere, and solidarity with the United States was no longer a matter of diplomatic maneuvering but of shared defense. President Ávila Camacho, who had succeeded Cárdenas in 1940, declared war on the Axis powers in May 1942, following the sinking of Mexican oil tankers by German U-boats. This marked a pivotal moment, transforming Mexico from a neutral observer into an active participant in the Allied cause.

Mexico's entry into the war, though primarily symbolic in terms of direct combat, had significant implications. The country contributed vital raw materials, including oil, minerals, and agricultural products, to the Allied war effort. Crucially, Mexico provided the "Escuadrón 201" (Squadron 201), an air force unit that fought alongside U.S. forces in the Pacific theater, primarily in the Philippines. This was a significant moment of national pride and a testament to Mexico's commitment to the Allied cause. The participation of Escuadrón 201 demonstrated Mexico's capacity and willingness to contribute on the battlefield, solidifying its status as an ally.

The war also had profound economic and social consequences for Mexico. Increased demand for its resources led to a period of industrialization and economic growth. However, it also created new dependencies on the U.S. and led to labor shortages as many Mexicans migrated north to work in U.S. industries under the Bracero Program. The experience of participating in a global conflict, alongside its powerful northern neighbor, fundamentally reshaped Mexico's international outlook and its relationship with the rest of the world. The period between Hitler and

Roosevelt was thus a crucial formative experience, shaping Mexico's identity and its place on the global stage.

Legacy and Conclusion

Mexico's journey between the looming threat of Hitler's fascism and the strategic embrace of Roosevelt's United States was a testament to its diplomatic acumen and its unwavering commitment to national sovereignty. It navigated a perilous geopolitical landscape, asserting its independence while recognizing the necessity of alliances in a world teetering on the brink of global conflict. The legacy of this period is one of resilience, a demonstration of how a developing nation could skillfully manage its foreign relations amidst immense international pressure.

The expropriation of oil, the reception of Spanish refugees, and the eventual declaration of war all underscore Mexico's agency in shaping its own destiny. The Good Neighbor Policy, while imperfect, provided a framework for a more equitable relationship with the United States, a relationship that would continue to evolve in the post-war era. Mexico's experience between Hitler and Roosevelt serves as a compelling case study in how nations, even those not at the forefront of global power, can exert influence and protect their interests in a complex and dangerous world. It highlights the intricate interplay of nationalism, economics, and diplomacy in the face of existential global threats, solidifying its position as a key player in hemispheric affairs and beyond.
