The phrase "To the Lady Mitsuye Yamada" serves as a perpetual reminder of a woman who dared to speak, who dared to remember, and who dared to demand justice. Her legacy continues to inspire, encouraging us to confront uncomfortable truths, to advocate for the marginalized, and to recognize the transformative power of a single, unwavering voice. Her work and life are a vital part of the American story, a story that is richer and more complete because of her contributions.
