Then, in your main sheet, you can use VLOOKUP with the approximate match option (TRUE):

`=VLOOKUP(B2, GradingTable, 2, TRUE)`

1. B2 is the score to look up.

3. 2 indicates you want to return the value from the second column of the lookup table (the Grade).
4. TRUE specifies an approximate match, which is crucial for score ranges.

The Modern Approach with XLOOKUP

XLOOKUP, available in newer Excel versions, offers greater flexibility and is generally preferred over VLOOKUP. It can perform approximate matches similarly.

=XLOOKUP(B2, ScoreColumn, GradeColumn, "Invalid Score", -1)
```

Where ScoreColumn and GradeColumn are the respective ranges in your lookup table, and -1 indicates an exact match or the next smaller item, which is suitable for this scenario.

Common Pitfalls and Best Practices
