Berms and Catchment Drains

Berms are horizontal platforms incorporated into the slope face, typically at the base of each bench. They serve multiple purposes: acting as a barrier to prevent falling material from reaching the lower parts of the pit, providing access for maintenance and inspection, and aiding in the collection of surface water. Catchment drains are designed to channel surface water away from the slope face, reducing the risk of erosion and groundwater ingress.
