6. **Choose Connection Options:**
 1. **"Reconnect at sign-in":** This is crucial if you want the mapped drive to be available every time you log in to

your computer. By default, it's usually checked.

2. **"Connect using different credentials":** Check this box if you need to log in to the network share with a username and password that are different from your current Windows login.
7. **Click "Finish":** Windows will attempt to establish the connection. If prompted, enter the username and password for the network share.

Your newly mapped network drive will now appear under "Network locations" within "This PC," acting just like a local drive.

Method 2: Using Command Prompt (for advanced users or scripting)

For scripting or automating the process, the Command Prompt (cmd) is an invaluable tool.

Open Command Prompt as an administrator and use the ``net use`` command:

net use Z: \\ServerName\ShareName /persistent:yes
