If both the base case and the inductive step are successfully proven, then by the principle of mathematical induction, the statement $P(n)$ is true for all integers $n \geq n_0$. $\frac{k(k+1)}{2} + (k+1)$ Now, we need to algebraically manipulate this expression to arrive at the RHS of $P(k+1)$. We can find a common denominator:

$$= \frac{k(k+1)}{2} + \frac{2(k+1)}{2} = \frac{k(k+1) + 2(k+1)}{2}$$

Factor out $(k+1)$ from the numerator: $= \frac{(k+1)(k+2)}{2}$

This is exactly the RHS of $P(k+1)$. Therefore, we have shown that if $P(k)$ is true, then $P(k+1)$ is also true.

Inductive Step:

Inductive Hypothesis: Assume $P(k)$ is true for some arbitrary integer $k \geq 5$. That is, assume $2^k > k^2$.

To Prove: We need to show that $P(k+1)$ is true. That is, $2^{k+1} > (k+1)^2$.

Starting with the LHS of $P(k+1)$: $2^{k+1} = 2 \cdot 2^k$ Using the inductive hypothesis ($2^k > k^2$): $2 \cdot 2^k > 2 \cdot k^2$
 So, $2^{k+1} > 2k^2$. Now, we need to show that $2k^2 \geq (k+1)^2$ for $k \geq 5$. Let's compare $2k^2$ and $(k+1)^2$: $2k^2 \geq (k+1)^2 \iff 2k^2 \geq k^2 + 2k + 1 \iff k^2 - 2k - 1 \geq 0$ Consider the quadratic $f(k) = k^2 - 2k - 1$. The roots of $k^2 - 2k - 1 = 0$ are given by the quadratic formula: $k = \frac{-(-2) \pm \sqrt{(-2)^2 - 4(1)(-1)}}{2(1)} = \frac{2 \pm \sqrt{4+4}}{2} = \frac{2 \pm \sqrt{8}}{2} = \frac{2 \pm 2\sqrt{2}}{2} = 1 \pm \sqrt{2}$. Since $\sqrt{2} \approx 1.414$, the roots are approximately $1 + 1.414 = 2.414$ and $1 - 1.414 = -0.414$. The parabola $k^2 - 2k - 1$ opens upwards, so it is non-negative for $k \geq 2.414$. Since our assumption is $k \geq 5$, the inequality $k^2 - 2k - 1 \geq 0$ (and thus $2k^2 \geq (k+1)^2$) holds true for all $k \geq 5$. Therefore, we have the following chain of inequalities: $2^{k+1} = 2 \cdot 2^k > 2k^2 \geq (k+1)^2$ (for $k \geq 5$)

5\$) This implies $2^{k+1} > (k+1)^2$. So, if $P(k)$ is true, then $P(k+1)$ is true.

Conclusion: By the principle of mathematical induction, $2^n > n^2$ is true for all integers $n \geq 5$. This is a good example of **proving inequalities by induction**.

Variations of Mathematical Induction
