It challenges the simplistic portrayal of a unified colonial vision and highlights the internal conflicts and ideological battles that shaped the nascent American experiment.

Morton's emphasis on secular concerns – trade, economic opportunity, and personal liberty – resonates with modern sensibilities, even as his criticisms of religious extremism remain relevant. He represents a secular, pragmatic, and somewhat bohemian alternative to the rigid, religiously motivated colonial project. His life and writings are a testament to the fact that early America was a place of diverse ambitions, clashing ideologies, and individuals who dared to chart their own course, even in the face of overwhelming opposition. The "maverick of New English Canaan" reminds us that history is rarely as simple as the victors wish to portray it, and that even within the most rigid societies, dissenting voices can emerge, offering alternative visions of what it means to build a new world.
