This demonstrates maturity and team-orientation.

"What are your strengths?"

This shows you're not just looking for any job, but *this* job.

"Where do you see yourself in 5 years?"

This probes your career ambition and alignment with the company's growth trajectory. Your answer should demonstrate ambition, but also realism. Ideally, you'll express a desire to grow within the company, take on more responsibility, and contribute to its long-term success. Avoid answers that suggest you'll be looking to move on to another company or industry. Focus on skill development, increasing contributions, and taking on more challenging roles within their organization. It's about your career path and how it intersects with their future.

"Why are you leaving your current job?"

Be positive and professional. If you're currently employed, focus on seeking new challenges, career growth, or a better alignment with your long-term goals. Avoid speaking negatively about your current employer, colleagues, or the job itself. If you were laid off, you can briefly and factually explain the situation without dwelling on it. Frame it as an opportunity to find a role that better suits your skills and aspirations. This is about your professional transition, not a complaint session.

Technical and Role-Specific Questions

These questions are designed to assess your proficiency in the specific skills and knowledge required for the role. They can range from coding challenges in software engineering to case studies in finance

or diagnostic scenarios in healthcare. Preparation is key here. Thoroughly review the job description and brush up on the required technical skills. If possible, practice answering common technical questions related to your field. Be prepared to explain your thought process, not just provide the answer. This showcases your understanding and problem-solving approach. For example, a developer might be asked to explain their approach to debugging a specific type of error, or a marketer might be asked to outline a strategy for a new campaign.
