As younger generations grapple with complex societal issues, CCM artists will be challenged to offer relevant and meaningful responses that resonate with their experiences. Whether through intimate acoustic sets, bombastic arena anthems, or socially conscious hip-hop, the enduring purpose of CCM will remain: to offer a compelling and accessible expression of Christian faith in the contemporary world.
