"Tell me about a time you faced a challenging situation at work and how you overcame it."

This question assesses your problem-solving skills, resilience, and ability to handle adversity.

Why they ask: To understand your approach to problem-solving, your emotional intelligence, and your ability to remain calm and effective under pressure.

How to answer: Use the STAR method:

1. **S - Situation:** Briefly describe the context of the situation.
2. **T - Task:** Explain the specific task you needed to accomplish.
3. **A - Action:** Detail the steps you took to address the situation.

4. **R - Result:** Describe the outcome of your actions and what you learned.
