Its notoriety, however, has been amplified by sensationalism and a tendency to overlook the more mundane, yet equally deadly, explanations for maritime and aviation tragedies. While the allure of the unknown will likely keep the legend alive, a rational examination reveals a more grounded, and perhaps more sobering, reality of why the Bermuda Triangle has earned its reputation.
