`=IF(C2="Completed", TODAY(), "")`

This formula checks if C2 contains the text "Completed". If it does, it inserts the current date using the `TODAY()` function. If not, it leaves the cell blank.

Statements

While a single IF function can handle basic two-way decisions, real-world scenarios often require more complex branching logic. This is where **nested IF statements** come into play. A nested IF is simply an IF function within another IF function, allowing you to create multiple conditions and outcomes.

How to Structure Nested IFs

Example of Nested IFs: Tiered Commission Rates

Example: Bonus Eligibility

Let's say an employee gets a bonus if they meet two conditions: their sales (in B2) are over \$10,000 AND they have a customer satisfaction score (in D2) of 90% or higher. If they meet both, they get a bonus of \$500; otherwise, they get nothing.

```
=IF(AND(B2>10000, D2>=0.9), 500, 0)
```

Here, the AND function ensures both conditions must be met for the logical_test to be TRUE.

Example: Overtime Calculation

An employee is eligible for overtime pay if they worked more than 40 hours (in E2) OR if their manager (in F2) has approved overtime. If eligible, overtime is paid at 1.5 times their hourly rate (in G2); otherwise, it's 0.

```
=IF(OR(E2>40, F2="Approved"), E2*G2*1.5, 0)
```

The OR function allows for flexibility; meeting either condition triggers the overtime pay calculation.

Best Practices and Tips for Using the IF Function

As you become more comfortable with the IF function, adopting good practices will make your spreadsheets more robust and easier to manage.

1. Keep it Simple When Possible

Before nesting IFs, consider if there are simpler alternatives. For instance, the **IFS function** (available in Excel 2019 and Microsoft 365) offers a cleaner way to handle multiple conditions without deep nesting. Its syntax is `IFS(logical_test1, value_if_true1, [logical_test2, value_if_true2], ...)`. 2. Use Cell References Instead of Hardcoding Values

Whenever possible, refer to cells that contain your thresholds or values. This makes it easy to update your logic by simply changing a value in a single cell, rather than editing multiple formulas. For example, instead of `IF(A2>10000, A2*0.05, A2*0.03)`, use

references like IF(A2>Threshold1, A2*Rate1, A2*Rate2) where Threshold1, Rate1, and Rate2 are in separate cells.

3. Format Your Formulas for Readability

For complex nested IFs, it's easy to lose track of parentheses and arguments. Use line breaks (Alt+Enter within the formula bar) and indentation to visually structure your formulas. This greatly improves clarity, especially when collaborating with others or revisiting your work later.

Example of formatted nested IF:

=IF(B2>10000,  
    B2*0.05,  
    IF(B2>5000,  
        B2*0.03,  
        0  
    )  
)
```

4. Understand Data Types

4. **Inspect Data:** Make sure the data in the cells being referenced is what you expect. Trailing spaces or incorrect formatting can cause issues.

Common Errors and How to Avoid Them

4. **Over-Nesting:** While nested IFs are powerful, excessively deep nesting can become unmanageable and error-prone. Consider alternatives like IFS, VLOOKUP, XLOOKUP, or even VBA for highly complex logic.
