This involves rolling a d20 and adding their attack bonus (which is usually their proficiency bonus plus the relevant ability score modifier, like Strength for melee weapons or Dexterity for ranged weapons). This total is compared to the target's Armor Class (AC).

If the attack roll meets or exceeds the target's AC, the attack hits. A roll of 1 is a critical failure, and a roll of 20 is a critical hit, typically doubling the damage dice. The DM

often adjudicates attacks, describing the success or failure and the impact of the blow.

Damage Rolls: Inflicting Wounds

When an attack hits, the attacker rolls damage dice to determine how much harm they inflict. The type and number of dice used depend on the weapon or spell. For example, a longsword might deal 1d8 slashing damage, while a fireball spell could deal 8d6 fire damage. Modifiers, such as the Strength modifier for melee attacks, are often added to the damage roll.

Damage reduces a creature's Hit Points (HP). When a creature's HP reaches zero, they fall unconscious and begin making death saving throws. If a creature takes a significant amount of damage in a single blow, they might be instantly killed or suffer lasting injuries, as determined by the DM.

Armor Class (AC): Staying Protected

Armor Class represents a creature's ability to avoid being hit. It's a combination of their natural defenses, armor worn, and Dexterity. Higher AC values make a creature harder to target successfully. Different types of armor provide varying AC bonuses, and some creatures have natural armor or other defensive abilities that contribute to their AC.

Saving Throws: Resisting Effects

Saving throws are rolls made to resist harmful spells, debilitating conditions, or environmental hazards. When a creature is subjected to such an effect, the DM will call for a specific type of saving throw (e.g., a Strength saving throw to break free from a grapple, or a Wisdom saving throw to resist a charm spell). The player rolls a d20 and adds their relevant saving throw bonus. If the total meets or exceeds the DC of the effect, they resist its full impact or avoid it entirely.

Spell Slots: Fueling Your Spells

Spells that require an attack roll function like weapon attacks, with the caster rolling a d20 and adding their spell attack bonus.

Cantrips are minor spells that can be cast an unlimited number of times per day. They are useful for basic damage or utility. Spells, on the other hand, are more powerful and consume spell slots. This distinction highlights the different levels of magical power available to characters.
