"Hard" multiculturalism might advocate for more extensive group rights, while "soft" multiculturalism prioritizes integration and general equality. Kymlicka's position is generally seen as a form of "soft" multiculturalism that prioritizes integration within a liberal framework.

Despite these criticisms, Kymlicka's work has been instrumental in pushing the boundaries of liberal thought and forcing a more serious engagement with the challenges of diversity. His ongoing contributions continue to address issues of global justice, democratic theory, and the future of the nation-state in an increasingly interconnected world.
