These columns reflect the account balances *after* the adjustments have been incorporated. The adjusted trial balance is

5. Income Statement Columns (Debit and Credit)

This section segregates the temporary accounts (revenues and expenses) from the permanent accounts. Revenue accounts, which normally have a credit balance, are listed in the credit column of the income statement section. Expense accounts, which normally have a debit balance, are listed in the debit column. The difference between the total credits (revenues) and total debits (expenses) in this section represents the net income or net loss for the period.

6. Balance Sheet Columns (Debit and Credit)

This section displays the permanent accounts. Asset accounts, which normally have a debit balance, are listed in the debit column. Liability and equity accounts, which normally have a credit balance, are listed in the credit column.
