The implementation phase requires critical thinking, clinical skills, and the ability to adapt interventions as needed. Nursing students are taught to document each intervention accurately and in a timely manner. This documentation is essential for demonstrating the care provided and for legal protection.

5. Evaluation: Assessing Progress and Revising the Plan

The final step of the nursing process is evaluation. Nursing students critically assess the patient's progress towards the established goals and outcomes. This involves comparing the patient's current status with the desired outcomes. Questions to consider include:

outcomes. This includes rationales for each intervention, often supported by evidence-based practice.

Rationale

The scientific justification for each nursing intervention. This demonstrates the student's understanding of **why** a particular intervention is being performed and its expected effect on the patient's condition. For nursing students, including rationales is crucial for developing critical thinking and solidifying their knowledge base.

Evaluation

A section to document the assessment of the patient's progress toward the stated outcomes and any necessary modifications to the care plan.

Signature and Date

Documentation of who created and updated the care plan, along with the date and time of entry.
