The faint smudges of light observed in telescopes, known as nebulae, were thought to be clouds of gas within our own galaxy. However, a persistent debate simmered. Were these nebulae distant island universes, or were they closer celestial phenomena? The key to unlocking this mystery lay in determining their distances. This is where Hubble's meticulous observations and keen intellect proved pivotal.

Working with the powerful Hooker Telescope at Mount Wilson Observatory in California, Hubble embarked on a mission to measure the distances to these nebulae. His primary tool was the identification of Cepheid variable stars. These pulsating stars have a direct relationship between their period of pulsation and their intrinsic luminosity, a discovery made by Henrietta Swan Leavitt. By observing the period of a Cepheid in a distant nebula, Hubble could determine its absolute brightness and, by comparing this to its apparent brightness, calculate its distance. These calculations would forever change our perception of the cosmos.

The Great Debate and the Andromeda Nebula

The late 1910s and early 1920s were a fertile ground for astronomical debate. The nature of nebulae was a central question. This discovery, announced in 1924, was a monumental revelation, expanding the known universe exponentially and confirming the existence of myriad other galaxies.

Hubble's Law: A Universe in Expansion

Hubble's monumental discovery of extragalactic nebulae was only the beginning of his profound impact. He, along with his assistant Milton Humason, continued to measure the distances to a large number of galaxies. Simultaneously, astronomers like Vesto Slipher had been measuring the radial velocities of these galaxies – how fast they were moving towards or away from us – by observing the redshift of their spectral lines. Redshift indicates that an object is moving away, while blueshift indicates it's moving closer.

What Hubble and Humason observed was astonishing. They found a consistent and remarkable relationship: the farther away a galaxy was, the faster it was receding from us. This direct proportionality between distance and recessional velocity is now known as Hubble's Law. In 1929, Hubble published his findings, which could be expressed mathematically as $v = H_0 d$, where 'v' is the recessional velocity, 'd' is the distance, and 'H₀' is the Hubble constant, representing the rate of expansion.

The Implications of an Expanding Universe

The discovery of an expanding universe had profound implications, challenging the static, unchanging universe that had been the prevailing model for centuries. If galaxies are all moving away from each other, it suggests that at some point in the distant past, they must have been much closer together. Extrapolating this expansion backward in time leads to a point where the entire observable universe was contained in an incredibly dense and hot state. This is the essence of the Big Bang theory.

While Hubble himself was cautious about fully embracing the term "Big Bang" (he preferred "Primeval Atom" or other descriptions), his empirical evidence provided the crucial support for the idea that the universe had a beginning. Georges Lemaître, a Belgian priest and physicist, had independently proposed a similar idea in 1927, suggesting that the universe began as a single, unimaginably dense point. Hubble's Law provided the observational confirmation that Lemaître's theoretical model needed.

The Big Bang Theory: From Evidence to Explanation

The Big Bang theory posits that approximately 13.8 billion years ago, the universe began as an extremely hot, dense singularity. This singularity rapidly expanded, and as it cooled, elementary particles formed, followed by atoms, and eventually stars and galaxies. The ongoing expansion observed by Hubble is a direct consequence of this initial event.
