Scenes depicted on amphorae, kraters, and kylixes offer vivid glimpses into ancient Greek stories and customs.

Prostitutes and hetairai (educated courtesans) occupied a distinct social space, sometimes wielding more influence than respectable wives due to their education and social interactions.

Slavery was a pervasive institution throughout ancient Greece, deeply embedded in its economy and social structure. * **Sources of Slaves:** Slaves were acquired through warfare, piracy, and birth. They performed a wide range of labor, from agricultural work and mining to domestic service and skilled crafts. * **Impact on Society:** The reliance on slave labor freed up citizens, particularly in Athens, to engage in politics, philosophy, and the arts, contributing to the flourishing of these domains. However, it also created a vast underclass and had profound ethical implications that were rarely questioned by mainstream society.

Education in ancient Greece varied by city-state and social class. * **Primary Education:** For boys of citizen families, education typically began with basic literacy, numeracy, music, and gymnastics. * **Higher**

Education: In Athens, affluent young men might attend a gymnasium for physical training and receive instruction from sophists, itinerant teachers who taught rhetoric, philosophy, and other subjects. The development of academies and philosophical schools, such as Plato's Academy and Aristotle's Lyceum, provided more structured and advanced learning for aspiring intellectuals. * **Limited Female Education:** Formal education for girls was rare, with most learning focused on domestic skills within the home. However, in some intellectual circles, women could gain access to knowledge through private tutors or by participating in philosophical discussions.
