1. Price Certainty for the Client

The primary allure for clients is the **fixed contract sum**. Once the contract is signed, the client has a clear understanding of the total cost of the project, assuming the scope remains unchanged. This predictability is

invaluable for financial planning, securing funding, and managing investment portfolios. It significantly reduces the risk of budget overruns, a common concern in construction projects.

2. Equitable Basis for Tendering

The standardized format of the BoQ ensures that all contractors are tendering on precisely the same basis. This eliminates the common pitfall of contractors including or excluding items differently, leading to seemingly attractive but misleadingly low bids. It allows clients to make informed comparisons between tenders, focusing on value for money rather than trying to decipher varying scopes of work.

3. Facilitates Cost Control and Valuation

The BoQ acts as a powerful tool for cost control throughout the construction phase. Interim valuations are straightforward; the quantity surveyor can remeasure the work executed and apply the pre-agreed rates from the BoQ. This process is transparent and objective, minimizing disputes over payment. It also allows for easy identification and costing of any necessary **construction variations**.

4. Reduced Risk for the Contractor (in certain

aspects)

While the contractor takes on the risk of pricing accurately, the defined scope and quantities in the BoQ provide a degree of protection against variations in material prices if the contract is structured to account for this (e.g., through fluctuation clauses). The clear definition of work also helps prevent scope creep and misunderstandings that can lead to disputes and claims. The contractor is generally paid for the quantities executed at the agreed rates, irrespective of their actual cost of materials or labor, provided they were diligent in their pricing.

5. Efficient Administration

The structured nature of the contract, with the BoQ as its backbone, streamlines administrative processes. Progress payments, variation assessments, and final account reconciliation are all facilitated by the detailed breakdown of work provided in the BoQ.

Potential Disadvantages and Considerations

Despite its strengths, the standard building contract with quantities is not without its potential drawbacks:

1. Initial Cost and Time Investment

Preparing a detailed and accurate Bill of Quantities is a time-consuming and costly process. It requires skilled quantity surveyors and a well-developed design. This upfront investment can be significant, especially for smaller projects.

2. Risk of Inaccurate Quantities

The entire integrity of the contract rests on the accuracy of the BoQ. Errors or omissions in the BoQ can lead to significant disputes and financial implications. If the BoQ underestimates quantities, the contractor may incur substantial losses as they will be paid for the actual (lower) quantity measured, not the estimated quantity. Conversely, overestimations might deter competitive bidding or lead to claims for remeasurement.

3. Contractor's Pricing Risk

The contractor bears the risk of pricing the items in the BoQ correctly. If their rates are too low, they may make a loss. If they are too high, they may not win the tender. This requires considerable expertise and market knowledge from the contractor's estimating team.

4. Less Flexibility for Design Changes

Once the contract is awarded, significant design changes

can be more complex and costly to implement. While variations are accommodated, they often involve re-pricing and negotiation, which can disrupt the project schedule and budget. It is therefore crucial that the design is as complete and finalized as possible before the tender stage.

5. Potential for Claims if BoQ is Defective

If the BoQ is found to be deficient (e.g., missing items, ambiguous descriptions), contractors may be entitled to submit claims for additional costs incurred, which can undermine the initial price certainty.

Common Contract Forms Utilizing Bills of Quantities

Several well-established standard form contracts incorporate the use of Bills of Quantities. In the UK and many Commonwealth countries, the **Joint Contracts Tribunal (JCT)** suite of contracts is highly prevalent. The JCT Standard Building Contract with Approximate Quantities (SBC/AQ) and JCT Design and Build Contract (DB) can be used with or without a BoQ. However, a more direct fit for a fixed-price contract based on detailed quantities is the **JCT Standard Building Contract (SBC)**, particularly when used with a fully priced BoQ. Internationally, organizations like the **International Federation of Consulting Engineers (FIDIC)** offer

forms of contract, such as the FIDIC Red Book (Conditions of Contract for Construction), which can be adapted to include a Bill of Quantities, although it often defaults to a "measure and value" basis without a pre-defined quantity schedule.

The choice of contract form will depend on project specifics, procurement routes, and the legal jurisdiction. However, the principle of using a BoQ to define a fixed price remains a consistent theme in many **construction procurement strategies**.

Best Practices for Using Standard Building Contracts with Quantities

To maximize the benefits and mitigate the risks associated with this contract type, adherence to best practices is crucial:

1. **Engage Competent Quantity Surveyors:** The accuracy and detail of the BoQ are paramount. Employ experienced and reputable quantity surveyors for its preparation.
2. **Complete and Finalize Design:** Ensure the design is as developed and complete as possible before issuing for tender. Incomplete designs lead to inaccurate BoQs.
3. **Thorough Tender Review:** Clients and their consultants should meticulously review tender

submissions, not just on price but also on the contractors' understanding of the project and their pricing strategy.

4. **Clear Variation Procedures:** Establish clear and well-documented procedures for handling variations, including pricing mechanisms and approval processes.
5. **Effective Contract Administration:** Maintain diligent contract administration throughout the project, with regular site visits, accurate progress recording, and timely payments.
6. **Open Communication:** Foster open and transparent communication between the client, contractor, and consultants to address any issues promptly.

Conclusion

The standard building contract with quantities stands as a robust and time-tested method for delivering construction projects. By providing a defined scope and a fixed price based on detailed measurements, it offers a high degree of financial certainty for clients and a clear framework for contractors. While the initial investment in preparing a comprehensive Bill of Quantities is significant, the subsequent benefits in terms of predictable costs, fair tendering, and streamlined administration often outweigh this upfront expenditure. For projects where budget adherence and clear expectations are paramount, the standard building contract with quantities remains an indispensable tool in

the arsenal of effective construction procurement and project management.
