The Austro-Hungarian and Ottoman Empires were dissolved, giving rise to new nation-states such as Poland, Czechoslovakia, Yugoslavia, and others. While this was in line with the principle of self-determination for some nationalities, it also created new ethnic tensions and border disputes that would plague the continent for decades.
