1. Prepare Your Chillies and Aromatics:

1. For dried chillies: Gently toast them in a dry skillet over medium-low heat until fragrant (about 1-2 minutes). Be careful not to burn them. 4. **Shelf Life:** Properly made and stored, homemade chilli oil can last for several months. Look for any signs of spoilage, such as mold or an off smell.

Troubleshooting Common Chilli Oil Issues

1. **Too Mild:** Use more chillies, or a hotter variety, in your next batch. Ensure your chillies are fresh and potent.
2. **Too Spicy:** Next time, use fewer chillies or a milder variety. You can also balance the heat by adding a touch more oil or a pinch of sugar during the steeping process.
