5. Is adept at presenting a persuasive defense, challenging witness testimony, and cross-examining effectively in court.
6. Is knowledgeable in the processes of post-conviction relief and appeals.

Without competent legal representation, a defendant's prospects for achieving relief are severely compromised. The selection of appropriate legal counsel represents a critical and foundational decision in confronting criminal accusations.
