Despite the criticisms, "The Clash of Civilizations" continues to resonate in contemporary international relations. The events of the early 21st century, including the September 11th attacks and the subsequent global "War on Terror," seemed to many to validate Huntington's predictions. The rise of extremist ideologies, often framed in religious terms, and the growing assertiveness of non-Western powers have further fueled discussions about civilizational identities and potential conflicts. The ongoing geopolitical tensions between the West and countries like China and Russia, while not solely driven by cultural differences, certainly have a civilizational dimension. The increasing focus on identity politics, both within nations and on the international stage, can be seen as a manifestation of the broader trends Huntington identified. His framework offers a lens through which to understand the complexities of a multipolar world, where traditional alliances are shifting, and cultural and religious factors play an increasingly prominent role in shaping foreign policy and international relations. Even if one rejects its deterministic conclusions, Huntington's thesis serves as a powerful reminder of the deep-seated cultural undercurrents that shape global affairs. The legacy of "The Clash of Civilizations" lies in its ability to provoke crucial questions about identity, belonging, and the potential for conflict in an increasingly interconnected, yet culturally diverse, world. The concept of civilizational alliances and rivalries remains a potent analytical tool for understanding global shifts.

In conclusion, Samuel Huntington's "The Clash of Civilizations" remains a pivotal, albeit contentious, work in understanding global dynamics. While its deterministic predictions and essentializing categories have been rightly challenged, the thesis compels us to consider the profound influence of cultural and religious identities on international conflict. In a world still grappling with the aftermath of ideological struggles and navigating the complexities of globalization, Huntington's insights, even those we debate and dissent from, continue to inform and provoke vital conversations about the future of global order.
