While body waves travel through the entire volume of a solid, surface waves are confined to the boundaries or

In solid mechanics, diffraction effects are important in understanding stress concentrations around cracks and holes, and in non-destructive testing methods where detecting internal flaws often relies on observing how ultrasonic waves diffract around them.

Interference and Diffraction Gratings

When two or more elastic waves meet, they can interfere with each other, either constructively (amplifying each other) or destructively (canceling each other out). This principle is exploited in techniques like acoustic microscopy and in the design of specialized materials with tailored wave-manipulating properties. Concepts akin to diffraction gratings, used to split light into its constituent wavelengths, can also be applied to elastic waves for spectral analysis.
