Organizations like the Black Panther Party, while often misunderstood and targeted by law enforcement, embodied aspects of "by any means necessary" through their community programs and their

armed patrols to monitor police brutality. The phrase became shorthand for a militant, unapologetic stance in the face of racial injustice.
