Newell's work reminds us that literary classics are not static entities. They are living, breathing works that can be re-examined, re-interpreted, and re-imagined. His Alice invites us to look beyond the surface, to appreciate the underlying currents of strangeness and wonder that make Wonderland so captivating. For anyone seeking a deeper, more artistic engagement with Lewis Carroll's timeless tale, Peter Newell's *Alice in Wonderland* offers a rich and rewarding journey into the heart of the surreal.
