The evolution of feminist theory, incorporating diverse perspectives and addressing complex issues of power and oppression, owes a significant debt to Wollstonecraft's pioneering efforts. Discussions of intersectionality and the critique of the patriarchy find their intellectual lineage in her foundational work.
