6. Did you interact with the dog before the alleged bite? If so, describe the nature of your interaction.
7. Did you touch, tease, taunt, or provoke the dog in any way? If so, describe your actions in detail.
8. Were you in possession of any food, toys, or other items that might have attracted the dog's attention?
9. Did you have permission to be on the property where the incident occurred? If not, why were you there?
10. Did you observe any warning signs or fences indicating the presence of a dog? If so, what did they say?
11. What was the approximate distance between you and the dog when you first observed it?
12. Did the dog bark, growl, or exhibit any aggressive behavior before the alleged bite?
13. Were there any other individuals or animals present at the time of the incident? If so, identify them.
14. Describe your physical condition at the time of the incident (e.g., were you running, startled, injured?).

These questions are designed to paint a clear picture of the plaintiff's involvement. Any hint of provocation, unexpected intrusion, or actions that might have startled the animal can be crucial for the defense. Remember, many dog bite statutes consider whether the owner was negligent *and* whether the victim was lawfully on the premises and not provoking the animal.

3. Prior Incidents and Dog's History

A dog's history of aggression or biting is a significant factor in determining liability, especially in strict liability states. These interrogatories aim to uncover any prior warnings or incidents involving the dog.

Sample Interrogatories:

1. Has the dog ever bitten or attempted to bite any person or animal before the incident on [Date of Incident]? If so, for each prior incident, provide:
 1. The date of the incident.
 2. The location of the incident.

Unearthing a dog's aggressive past can significantly strengthen the defense's position, especially if it wasn't disclosed. It can show that the owner was aware of a propensity for biting and failed to take adequate precautions. This is particularly relevant when discussing the "knowledge" element of a negligence claim, or even in strict liability cases where there might be nuances about whether the owner knew or should have known about the danger.

4. Fencing, Restraint, and Containment

The adequacy of the dog's containment is a critical factor in assessing the owner's negligence. These questions explore how the dog was kept and whether the containment was sufficient.

Sample Interrogatories:

1. Describe the fencing or enclosure where the dog was kept at the time of the incident. Provide dimensions, height, material, and any defects or breaches.

6. Witnesses and Evidence

Identifying any individuals who may have witnessed the incident or possess relevant evidence is vital for building the defense case.

Sample Interrogatories:

1. Identify all individuals who you believe witnessed the incident, or any part thereof. Provide their names, addresses, and telephone numbers.
2. Were any photographs or videos taken of the dog, the scene of the incident, or your injuries? If so, identify the person who took them and their current whereabouts.
3. Have you or anyone on your behalf obtained any written statements from witnesses? If so, identify the witness and the

custodian of the statement.

4. Do you have any documents or other tangible evidence in your possession or control that relates to this incident? If so, describe each item.

Witness testimony can corroborate or contradict a party's version of events. Identifying potential witnesses early on allows the defense to interview them and assess their potential impact on the case. Similarly, photographic or video evidence can be incredibly persuasive.

Legal Considerations and Best Practices
