The marriage was never consummated, and Henry quickly sought an annulment. Anne, understanding her precarious position and the king's displeasure, wisely agreed to the dissolution of the marriage. She was granted a generous settlement, including generous estates and the title "The King's Beloved Sister." She remained in England, a respected figure, outliving Henry and all his other wives.
