The author demonstrates a deep familiarity with Jewish law, customs, and Old Testament prophecy, often quoting or alluding to scripture to show how Jesus fulfills ancient Messianic expectations. The detailed knowledge of tax collection and financial matters, evident in passages like the miraculous catch

of fish and the coin in the fish's mouth, aligns with the background of a tax collector. Furthermore, the inclusion of tax-related parables, such as the Parable of the Unmerciful Servant, might also point to an author with firsthand experience in such matters. The Greek in which the Gospel is written is sophisticated, suggesting a well-educated individual, though the theory of a Hebrew original cited by Papias continues to be a point of discussion among biblical scholars, with many believing Matthew may have originally composed his work in Aramaic or Hebrew and it was later translated into Greek. Other scholars propose that "Matthew" refers to a disciple, but not necessarily the Apostle, or that the Gospel is a compilation of earlier traditions attributed to Matthew.

Alternative Theories and the Synoptic Problem

The "Synoptic Problem" refers to the observed similarities and differences between the Gospels of Matthew, Mark, and Luke. Many scholars believe that Mark was written first, and that Matthew and Luke drew upon Mark as a source, along with another hypothetical source known as "Q" (from the German word **Quelle**, meaning "source"). This theory, while influential, does not necessarily negate traditional

The repeated phrase "kingdom of heaven" (rather than "kingdom of God," as in Mark and Luke) is a Jewish circumlocution for God, further indicating a Jewish readership. While Gentile inclusion is not absent, the primary focus appears to be on presenting Jesus as the promised Messiah to his Jewish brethren.

This intertwining of the Old and New Testaments is a defining characteristic of Matthew's theological approach.
